Committee Member Reports

Maintenance

Laurie Swetkovich reported that the maintenance employee is proposing that the maintenance position's working dates be from April 15 – October 15 of each year. Laurie also reported that she will ensure that maintenance turns the water off at the beach/gazebo area.

Compliance/Patrol

Don Huibregtse reported that patrol has been quiet. Twenty-one letters were recently sent with fines for propane tanks and/or garbage cans being visible (the residents who received letters had already received a "warning" of non-compliance letter that did not include fines). An additional 9-10 letters informing residents of non-compliance items were sent today.

Architectural Control (ACC)

Les Dennis reported that there have not been many recent project permits. There may still a drainage issue on a lot on Mountain View, even though repairs have been made. The ACC will monitor.

James Byrne wanted to send a letter that he has drafted to a builder that changed the floor plan of a home without updating the LLVCC project permit. The builder had an approved permit from the county for the change, yet did not submit the change with the ACC. The board wants to review James's letter prior to delivery to the builder.

A property on Lakeshore had drainage into the lake, the county was notified, and the builder has made some repairs.

Lake Management

Peter Nash reported that several people need to learn how to adjust the valve at the lake. The process will be written down and videotaped to use as future training for staff and board members.

The next fish plant date is scheduled for October 21, 2022.

Peter will follow-up with the county about the back-up sewage pump to be installed near the beach/gazebo common area.
