Annual LLVCC Budget Meeting

Date: February 22, 2023

Voting members will be receiving the budget and a Proxy letter either by U.S. Postal Service or email in January or early February. Those members who have provided LLVCC with permission and an email address will receive the information via email, so please confirm your email address and permissions with the Office Coordinator.

Audit Nearing Completion

The audit firm of Clarke & Whitney CPA, Inc. is nearing completion of the financial audit of LLVCC's books for fiscal year 2021-2022. A draft audit was received and reviewed, and final adjustments are being made. Once the final audit is received it will be posted on the LLVCC website.

LLVCC Lake Management

Lake Management Update

As we're well into Fall, the lake will now have a near constant flow of water. Efficient and safe outflow is dependent on our weir being free of obstructions and blockages. We ask residents to ensure boats and other items are well secured. If you see something that could block the weir, please let the office know, or remove it if you are able.

Lake Stewardship

Lake Anderson is a designated environmental critical area, and much of the water run-off from our properties and roads ends up in the lake and the wild salmonbearing outflow creek. Please be mindful when landscaping or using herbicides, fertilizers, and chemicals.

Lake Weed Rake Loaner for Homeowner Use

We've had some recent success chemically controlling curly-leaf pondweed; however, eradication is near impossible. This is a good time of year to manually remove this invasive plant, so LLVCC has purchased a lake weed rake to lend to homeowners who want to take out patches of this weed only. Native plants in the water are not to be cleared.

The lakebed is owned and managed by LLVCC. As such we are requiring homeowners to follow state and county regulations for aquatic weed removal. Simple written instructions for pondweed identification and removal will be provided when you sign out the rake. Contact the LLVCC Office for more information. Walkers

It is difficult to see people walking after dark. Please wear light-colored or reflective clothing at night to minimize the possibility of an accident. Be sure to walk on the side of the road facing traffic. Keep your pets and young children close and safe.

LLVCC Compliance

Boats at Boat Launch

Boats stored at the boat launch area must be registered each year at the office April 1st. If you have not filled out a registration form and paid the storage fee for your boat for the 2022/2023 year, contact the LLVCC office immediately. A recent audit showed some boats out of compliance. The 2022/2023 sticker is red; please make sure to have the new sticker visible on your boat. Any boats not in compliance by December 15th will be auctioned or removed as junk.

Property Maintenance

Just a reminder to all homeowners that our community is preferred by many buyers for the clean and well cared for properties. We want to continue to provide this image to the public and encourage everyone to ensure that your yards are maintained as well as the parking strips and the ditch in front of the property.

Feeding Wildlife

Please do not feed wild animals (racoons, deer, bunnies). Feeding them makes them comfortable around humans and they can become aggressive if not fed by others. It is not healthy for wild animals to consume human or pet food. This practice also draws predators to our community like coyotes, cougars, and bears. There have been several bear sightings in homeowners' yards this year. Please be aware, if you have bird feeders in your yard, you are likely attracting bears and rats.

LLVCC Maintenance and Common Spaces

Common Areas

As winter approaches we need to remind homeowners that grounds and maintenance of our community are completed on a very limited basis between November and March. The approved budget for LLVCC's fiscal year of 4/1/22 to 3/31/2023 is minimal and kept dues at the previous year's level.

Two of the items that helped create a balanced budget were having no maintenance staff from November thru March, and the landscaper was approved to work only 40 hours total during this timeframe.

Once spring arrives, the crew will play catch up and do their best to keep our community clean, maintained, and beautiful.

Dog Poop

Please be sure to clean up after your pet as you enjoy strolls through the neighborhood. Pet poop bags are located around the community for your convenience. Before disposing of the poop bags into community trash cans, please tie a knot so that the feces do not spill out.

No Dogs in Tennis or Basketball Courts

Please do not allow your dogs to play on the tennis or basketball courts. Their urine and feces will adhere to the balls and transfer to players' hands. For health and safety reasons, please respect this request.

Property Owner & Rental Property Owners

If your contact information has changed, phone numbers, mailing address, or email, please contact the LLVCC office with the information.

Please make sure that your house numbers are easily visible from the street. This aids our mail carriers and delivery people, as well as emergency responders. Make sure that bushes and trees do not obscure your address and name sign.

Rental Properties

If you are using your property as a rental, it is a requirement of LakeLand Village Community Club to have the tenant's information on file. Please submit your renter's information to the LakeLand Village Community Club Office.

After Hours Drop Box

LLVCC has installed a locking mailbox at the clubhouse, in the drive through area. This mailbox will be used as an afterhours drop box for LLVCC HOA business and LakeLand Village water. The drop box will be checked by office staff during business hours.
