EDUCATION CORNER

This is a new addition to the newsletter. In each edition, we will cover one Resolution or topic from our Covenants or Bylaws to discuss and clarify.

Budget and Elections Meeting

According to the By-Laws of the LLVCC, Article II Membership, Subsection D Meetings, Number 1, Annual Membership Meeting: "There shall be a budget and election annual membership meeting in February of each year...". This year's meeting will take place at 7:00, Wed., Feb. 28 at the LLV Clubhouse.

At this meeting, the proposed budget for Fiscal Year 2024-25 will be voted upon by the community, three Board seats are up for re-election, an audit needs to be approved or waived, and we are giving members the option to be part of a new directory, which can include phone numbers.

At the meeting, a quorum must be reached. According to the By-Laws of the LLVCC, Article II Membership, Subsection D Meetings, Number 6, Quorum: "A quorum for the transaction of business at any general membership meeting shall be 10 percent of the total number of votes of eligible voters, voting either in person, by electronic communication, or by mail". Quorum is 94.

According to the By-Laws of the LLVCC, Article II Membership, Subsection D Meetings, Number 7, Ballots: "A member may cast his or her vote in person, by electronic communication, or by mail, according to procedures established by the Board of Directors." Paper ballots and an electronic ballot will be available. Voters may use either, but obviously not both.

Article II Membership, Subsection D Meetings, Number 8, Majority, states "Actions of the membership shall be taken by a majority vote of the members in good standing, voting at a meeting with a quorum...". Members in good standing are those "members who are not more than 90 days delinquent in the payment of any amount due to the Association, unless a repayment agreement has been reached and is complied with." (By-Laws, Article I General Provisions, Subsection F Definitions, Number 5 Members in Good Standing.)

LAKE MANAGEMENT

We have had numerous calls about otters in the lake. The USDA does not trap and remove otters, as it is prohibitively expensive and not very effective, as they will come and go on their own. They will trap and euthanize beavers, as they can cause an environmental hazard by removing threatened and protected shore vegetation.

According to the WDFW, otters prefer small, slower moving fish, such as young bass and bluegill, which are slowed down by our colder water temperatures in the winter.

They may take some rainbow trout, which we stock in the fall, but they are faster and over 10" when planted. Concerns about the otters affecting availability of fish for the derby seem unfounded by last year's derby results, which were some of the largest in several years.

We have also had concerns about the weeds in the lake. Native pondweed can be problematic, but not as much of a concern as the invasive curly leaf pondweed. Both are treated at least twice a year, but the water temperature must be 60 degrees for the herbicide to work. The office has a weed rake that can be checked out by residents if you wish to clear your shoreline of these plants.

Strategic Planning Workgroup

This group sent out a survey earlier this year and received feedback from the community; your suggestions are being considered to create a five-year plan proposal that was submitted to the Board at the December meeting. The results of the survey will be posted to the llvcc.com website soon.

Reminder to share our roadways.

Washington State Law (RCW 46.61) states that pedestrians must use sidewalks when available. If they are not available, as in LakeLand Village, pedestrians must walk on the left side of the roadway or its shoulder, facing traffic.

Every intersection is a crosswalk. Drivers must stop for pedestrians at intersections, whether marked or unmarked. Bicyclists count as pedestrians in crosswalks.

The best way for pedestrians and drivers alike to avoid collisions is to be prepared and be aware. While the law assigns pedestrians the right of way, it does not relieve pedestrians of using due care for their own safety. Pedestrians should wear lighter colored clothing, especially after dark or on gloomy days, and should stay as close to the left side of the road as possible, moving out of the roadway when a vehicle comes by. Drivers shall exercise due care to avoid colliding with any pedestrian on the roadway and shall give warning by sounding the horn when necessary.
