Beach Opening

With warmer weather on its way, the beach season is upon us. The gazebo beach will be staffed beginning Memorial Day weekend, then weekends until school is out. Beginning on June 15th, beach staff will be in attendance from 12:00 – 6:00 pm daily. Their main task is to ensure peaceful use of our facilities; they are not lifeguards, even though we are providing them with training in CPR. Children should be supervised by their parents while swimming. Please be sure your vehicles have LLV stickers on them. Stickers can be obtained at no cost at the office. If you invite guests, please accompany them.

The gazebo is available for LLV residents to reserve. Reservation forms can be found at the office or online at llvcc.com, under Important Documents. Please submit requests to the office at least a few days prior to your desired use. We already have some dates reserved. If there is not a reservation, the gazebo, tables, and grills may be used on a first-come, first-served basis.

We expect that with summer coming, the playground will also be getting more use. If there are problems with the equipment, please let us know. We will also be cleaning up the horseshoe pits for community use. The office has two sets of horseshoes that may be checked out for residents' use. Contact the office to borrow.

EDUCATION CORNER

Solicitors

The LLV office receives numerous calls a month complaining about solicitors coming through the neighborhood. There is nothing in the Bylaws or Covenants concerning solicitation; there cannot be. Our roads are county-owned, so we cannot deny access to members of the public. The "No Soliciting" signs at Homestead and Lakeland Dr probably discourage some solicitors, but obviously not all. The best we can do is encourage individual homeowners to post their own property. I know this is not a satisfactory response, but it is the only one available to us at this time. If you post your property and continue to have an issue, it would be a matter for Mason County Sheriff.

BOARD NEWS Budget & Elections

At the February Community Budget and Election meeting, the proposed budget was passed. It can be viewed on the website, llvcc.com.

The currently sitting Board members who were up for re-election, James Byrne, Don Huibregtse, and Mark Murray, were all re-elected for another 3-year term. The Board elected officers at the March meeting. James Byrne and Sylvia Banzon continue as President and Secretary/Treasurer, respectively. Mark Murray was nominated and confirmed as Vice President.

Since then, we have had a board member resign, so we have an **open position** on the board. If you are interested in serving your community as a board member, please contact the office and plan to attend the May Board meeting, when the appointment will be made.

LAKE MANAGEMENT

The Lake Management Committee is now being chaired by Scott Horsfall. He assumed the chairmanship upon the resignation of the previous committee chair, Peter Nash.

The Lake will be treated for curly pondweed and other invasive weed species between the dates of May 19th and 31st. The office will send out an email specifying the exact date once we know what it will be.

COMPLIANCE AND PATROL

FOR WALKERS:

It is difficult to see people walking after dark, please wear light colored or reflective clothing at night to minimize the possibility of an accident.

LakeLand Village has many walkers and many blind curves and hills. Please stay on the shoulder facing traffic whenever possible to minimize the possibility of an accident.

FOR DRIVERS:

Warmer weather means more adults and children are out and about enjoying our beautiful outdoors. When you are in your vehicles, please be extra vigilant and maintain the legal speed limit through LLVCC of **25MPH**.

GENERAL COMMENTS:

Pride in our properties means that Lakeland Village residents will be doing outside spring cleaning soon. Please be aware that burning yard debris is against LLVCC covenants.

The waste containers at the gazebo area are for HOA members taking advantage of the beach area and not for personal household waste.

There have been several incidents of vandalism during daylight hours at the playground restrooms. Fortunately, no serious damage was done that was not repairable. If you see someone in the act, please call the Patrol at (360) 340-3931 or during office hours (360)275-3508. If you know who is responsible, please call the office.

The water department wants to remind the community that when the power goes out in the neighborhood, our pumps and grinders do not work. Please be mindful and use water sparingly and try not to flush your toilets for the duration of a power outage.

The roads in LakeLand Village are county roads. Dirt bikes and quads are not legal on our county roads unless they have an Off-Road Vehicle decal and a motorcycle license plate. All drivers must have a valid driver's license to operate a vehicle on the roadways.

The Golf Course is **not** HOA property; it is PRIVATE PROPERTY owned by the Anderson Family. They have asked that residents respect Golf Course hours and do not use the golf cart paths for walking or bike riding. Please keep your dogs leashed and off the greens.
